NOTICE OF APPEAL OF FINAL AGENCY DECISIONS
REGARDING CLAIMS FOR INDIVIDUAL RELIEF

Class Counsel in this matter hereby notify the Commission that all Class Members appeal the Final Agency Decisions issued by the Agency regarding claims for individual relief. Class Counsel represents the interests of all Class Members, and Class Counsel intends for this appeal to include all Final Agency Decisions (or other dispositive decisions) issued by the Agency in this matter concerning any Class Member claim for individual relief. In other words, the scope of this appeal is class-wide, encompassing every Final Agency Decision (or other dispositive decision) issued by the Agency in this matter without a decision from the Administrative Judge concerning the Class Member's claim for relief.

The Class alleges that all Final Agency Decisions (or decisions dismissing or refusing to process claims) issued in this matter regarding Class Member claims for individual relief have been issued in error, and in violation of the EEOC's process for relief claims. *See* EEOC Management Directive 110 at Ch. 8 § XII(C). This Notice of Appeal therefore applies to every claim for individual relief submitted in this case. Further, the attached document includes the

name and contact information of every Class Member who has formally designated Class Counsel as his or her representative with respect to a claim for individual relief.¹ Thus, the scope of this Notice of Appeal specifically encompasses each Class Member claimant identified in the attached document, and also specifically encompasses all Class Member claims for individual relief.
